APPLICATION FOR SUMMER ARTS CAMP SCHOLARSHIP

Information and Guidelines:

- 1) Jenna's Dream Summer Camp Scholarships are open to students 6 – 13 years old.
- 2) Scholarships are awarded based mainly upon the following criteria: your child's demonstrated interest in the performing arts and the financial need for a scholarship opportunity.
 - a) **Provide a Statement of your Child's Interest:**

In addition to your description of why you think your child would be a good candidate for a Summer Camp Scholarship (see Application below), please include a letter of recommendation from a teacher in the arts for this applicant and/or proof of your child's previous activities in the performing arts (i.e. - receipts from previous summer camps, dance classes, etc.)
 - b) **Provide Confirmation of Financial Need:**

According to the by-laws of Jenna's Dream, Inc., our application to the I.R.S. for Tax-Exempt Status and the character of our organization, recipients of our Summer Theatre Arts Camp Scholarships should have a demonstrable financial need for such assistance.

In order to respect the privacy of the families of our scholarship applicants, Jenna's Dream, Inc. does not ask for any specific information to determine eligibility for tuition assistance. However, please include at least one letter from a reference who may attest (in a general way) to the financial need for this scholarship (i.e. – clergyman, guidance counselor other knowledgeable school official). Information regarding an applicant's financial need will be kept in confidence.
- 3) Jenna's Dream is expanding the number of camps that participate in our Summer Arts Camp Scholarship program.
 - a) Please **DO NOT** reserve a place in a specific camp or session for your child in the hope of receiving a scholarship. The Directors of the various camps that participate in our Summer Arts Scholarship program have allotted spaces for scholarship recipients according to their own scheduling needs.
 - b) An applicant may *request* a particular choice in a participating Summer Arts Camp program. However, the selection of camp and camp session dates will be assigned on a space-available basis and other factors, to be determined by Jenna's Dream and the various Camp Directors.
 - c) Applicant or Summer Arts Camp Director may contact Jenna's Dream to inquire about guidelines for inclusion in the Summer Arts Camp Scholarship program.
- 4) If my child is chosen as a scholarship recipient, I understand that I will be responsible for transportation to and from camp, as well as any and all additional Arts Camp fees. My child will follow all rules and regulations of the Summer Arts Camp that he or she child attends. I understand that Camp registration may require my child's medical, insurance and other information.

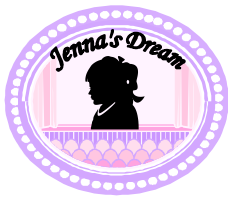
